The Park at Flat Rock is a staple for our community, promoting healthy living and happiness to those who take advantage of all the park has to offer. It is because of generous financial gifts that The Park continues to flourish and is truly making a difference in the lives of so many people. This year, The Park saw enhanced and expanded health and wellness programming – ALL thanks to the generosity of donors. In 2021, the Foundation received more than \$110,000 in gifts from 1,100 individuals.
